CONDITIONS OF APPROVAL

This approval is subject to following;

- 1. The manufacturer is to maintain effective quality system complying with the most current version of ISO 9000 series.
- 2. Each lifejacket is to be clearly marked with approval information as mentioned below
 - a) As per LSA code regulations I/1.2.2.9 and II/2.2.1.2.
 - b) As per NCD/3926, Issue-1, Oct 2015 Cl.7.1 and 7.2
- 3. The Stole of the lifejacket since procured from manufacturer M/s. JIAXING RONGSHENG LIFESAVING EQUIPMENT CO. LTD, China is to be supported with test reports of the sample of fabrics from each batch and is to retained as record. The compliance to the fabric requirements be ensured and the same be produced for verification by user or inspecting agencies.
- 4. Following are to be provided along with the product by the manufacturer as per the requirements of NCD/3926, Issue-1, Oct 2015
 - a) Instructions (Cl. 7.3): Specific instruction to be included to address that "Orally inflated lifejackets should not subsequently be inflated by gas." preferably by marking on the lifejacket.
 - b) Protective covers (Cl. 7.4)
 - c) Product life & Product support (Cl. 10)
 - d) Warranty (Cl. 11)
 - e) Spares (Cl.12)
 - f) Documentation (Cl. 13)
- 5. The lifejacket light used in the construction of lifejacket is to be of approved type and each lifejacket shall be fitted with a whistle firmly secured by a lanyard.
- 6. Lifejacket will require re-approval under following circumstances:
 - a) Any changes to the approved design parameters or construction or NCD/3926, Issue-1, Oct 2015 or LSA Code.
 - b) Any changes in the location/address of the manufacturer as stipulated in the certificate without informing IRS in writing.
 - c) Any alteration being made to the manufacturing facilities and product procedure
- 7. Records of the production tests in compliance with IMO Resolution MSC.81 (70) Part 2, Para 1 & 2 are to be maintained for review during annual surveillance audits.
- 8. This certificate remains valid subject to annual audits being carried out in accordance with Society's Requirements.
- 9. The Manufacturer is to declare that the shelf life of the battery and the light used is for five years and if utilized it can be replaced as a whole.
- 10.The inflation system as per NCD 3926 Issue-1, Oct 2015 includes components namely:

 1) Automatic system 2) Manual System 3) Oral System. Since Stole along with the inflation system being procured from M/s. JIAXING RONGSHENG LIFESAVING EQUIPMENT CO. LTD, China, the components of entire inflation system are to be sourced from approved vendors as mentioned in Type Examination Certificate of Lifejacket issued to the company mentioned above.
